**Date of Online Registration Process:**

From 06-May-2026, Wednesday at 11:00 Hrs to 10-May-2026 Sunday at 20:00 Hrs or on completion of batch allotted quota whichever is earlier.

**Training Fee:** Eligible students after successful physical verification of documents, will be required to pay **Rs. 4720/- per participant** including GST (Rs. Four Thousand Seven Hundred Twenty only) through net banking in the designated Account **(Non-refundable)**.

**Important Instruction for Summer Vacation Training – 2026**

1. All the three documents as mentioned above, needs to be uploaded while online Registration.
2. Do not pay the fee unless registration is confirmed by KTC. A list to that effect will be published on the website. Admission will be granted on a first-come, first-served basis.
3. Students are requested to adhere with the safety norms / practices strictly as framed by company, in premises and plant area. Any accident occurred during training period, KTC / MAHAGENCO will not be responsible for the mishaps, or any loss thereof. No claim will be entertained. An undertaking to that effect will have to be signed by the student and his/her parents. Selected students must submit accidental insurance of about Rs. 2 Lakh of any nationalized bank, as KTPS is prohibited restricted Industrial Area by GoM.
4. The trainees must make their own arrangements for lodging, boarding & conveyance etc. during the training period.
5. The detailed Training syllabus, Batch schedule and soft copy of study material will be provided to the candidate.
6. Any misconduct or misbehaviour by participant if observed during the training period, the participant will be debarred from further training and same will be informed to concerned college.
7. Leave / Absentee, reporting late for classes/visits shall not be allowed during training. The certificate will not be issued to the defaulter in any case.
